Move ups may be approved provided the next level class and judge are available and the class has not reached its limit.

Judges Will Not Wait For Any Dog Holding Up A Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. All dogs present must be held on leash or confined to their crates except when being judged.

AKC rules apply for class size limits, 15 dogs per hour for 8 hours of judging per day for the rally trial.
